FUND DESCRIPTION

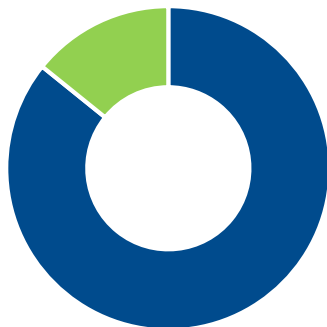
The Fund invests in a diversified manner in global equity markets including an allocation to emerging markets. The Fund is passively managed by Irish Life Investment Managers. It is designed to replicate (or track) the returns of the relevant equity market indices. Some of the currency exposures are hedged back to euro terms.

As the Fund invests entirely in shares it may be expected to exhibit a high level of volatility in line with the performance of global stock markets. The value of the Fund may therefore rise or fall considerably over relatively short periods (possibly by 30% or more). However in the long term the expected return from the Fund is greater than that expected from any of the other fund choices available under the Scheme. 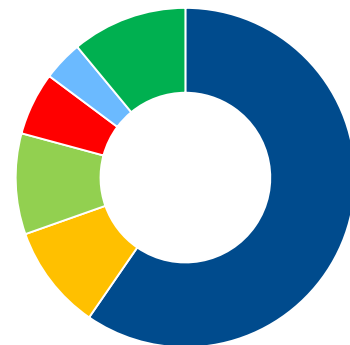
ASSET SPLIT - AS AT 31-05-2021
