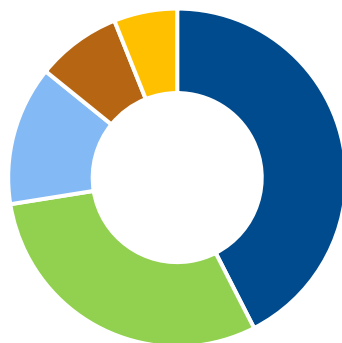
FUND DESCRIPTION

The CERS Multi Asset Fund ("the Fund") is designed to deliver competitive long term returns whilst limiting its exposure to the extreme downside which accompanies bear markets, particularly in Equities and Bonds. The fund is actively managed at the asset allocation level within controlled investment ranges which prescribe maximum and minimum exposure to each asset class. The allocation to each fund will vary from the central allocation within the investment range from time to time to take account of market conditions. CENTRAL ALLOCATION

The central allocation to each of the five sub funds will be subject to regular review by the Trustee who also reviews the managers and strategies used for each of the underlying funds on a regular basis.

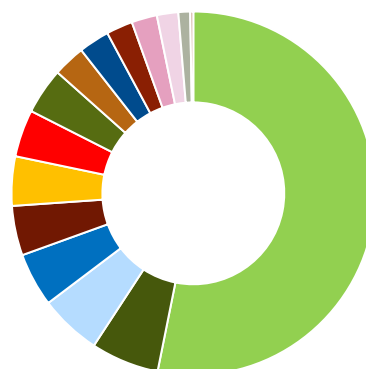
ASSET SPLIT - AS AT 31-05-2024
